CONTRACTS & PROPERTY COMMITTEE:

Business: The committee oversees all contract matters that are considered by the City of East Cleveland. The Committee is responsible for the redevelopment of blighted areas, the rehabilitation and conservation of properties, the alleviation of the housing shortage, economic and industrial development, land reutilization programs and all matters pertaining to the Departments of Community Development, Economic Development, and Building & Housing.

HEALTH & SAFETY COMMITTEE:

Business: The Health & Safety Committee handles all matters relating to public health and safety, including sanitation, police, fire, and the City's activities and legislation concerning health and welfare

FINANCE COMMITTEE:

Business: The Finance Committee is responsible for all financial matters of the city of East Cleveland, including passing a balanced budget annually and approving all city expenditures and appropriations. The committee conducts hearings on the general fund budget and other issues that have an impact on the financial health of the City. The committee oversees the appropriation and expenditure of the Community Development Block Grants, which fund programs like recreation and senior services.

GENERAL SERVICES & ADMINISTRATION COMMITTEE:

Business: The General Service Committee is responsible for all matters relating to street and sewer improvements, street cleaning, waste collection and disposal, bridges and underpasses and all matters relating to the City's Service Department. Responsible for all matters related to water supply, sewage, telecommunications, public utility rates, railway and railroad operations, and the Northeast Ohio Regional Sewer District. This committee handles all issues pertaining to Public Utilities

PERSONNEL & APPOINTMENTS COMMITTEE:

Business: The Personnel Committee reviews matters involving personnel policies that affect staff, and recommends various personnel policies to the Council. The committee provides recommendations and input into employee recruitment and compensation, and evaluation of employee performance.

EXECUTIVE COMMITTEE: City Council may meet in closed session before or after a meeting to discuss matters such as pending litigation, conference with real property negotiators, considerations for appointment, performance evaluation, discipline, dismissal, or release of a public employee. This is a closed session with all Council members.
