**WHEREAS**, the City of East Cleveland has a need for fire and emergency medical service equipment; and

**WHEREAS**, the City of Oakwood Village has generously agreed to donate one of its used fire trucks to the City of East Cleveland, which vehicle may be donated by the City of Oakwood Village without competitive bidding or advertisement if approved by Oakwood Village City Council; and

**WHEREAS**, the Council of the City of Oakwood Village has approved the donation of the Oakwood Village Fire Department's "2003 Horton Ambulance Squad Truck. VIN #IFDXE45F13HA90409."

**NOW, THEREFORE BE IT RESOLVED** by the City Council, East Cleveland, Ohio, three-fifths (3/5) concurring:

**SECTION 1.** The Mayor is hereby authorized to accept the donation of the 2003 Horton Ambulance Squad Truck. VIN #IFDXE45F13HA90409 from the City of Oakwood Village and is further authorized to execute the documents necessary to accomplish the purpose addressed in this legislation.

**SECTION 2.** It is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all such deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

**SECTION 3.** That this Resolution shall take effect and be in force from and after the earliest period allowed by law.


