

RESOLUTION NO. 02-18

A RESOLUTION AUTHORIZING THE MAYOR AND CITY COUNCIL TO ADVERTISE FOR BIDS IN THE AMOUNT OF UP TO TWENTY THOUSAND DOLLARS, \$20,000.00, FOR THE UPDATING, HARD COPY REPUBLICATION AND WEB POSTING OF THE CITY OF EAST CLEVELAND'S CHARTER AND CODIFIED ORDINANCES INCLUDING RECODIFICATION OF ALL LEGISLATION APPROVED SINCE 2000 UP UNTIL 2017 IN ORDER TO IMPROVE PUBLIC ACCESS AND COMPLIANCE.

WHEREAS, the City's Charter and codified Ordinances have not been updated and bound since 2000; and

WHEREAS, the procurement of such services will include recodification, hard copy republishing, web access, technical support, legal analysis, bound copies, minutes/agenda management as well as overall legislative management via the City of East Cleveland's website; and

WHEREAS, the updating and web publication of the City's Charter and Codified Ordinances will allow for easy navigation by East Cleveland's staff and residents.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of East Cleveland, Ohio, three-fifths (3/5) of all members concurring:

SECTION 1: That the Mayor and/or the City Council President, are hereby authorized to advertise for bids for the procurement for the updating, binding and web posting of the City of East Cleveland's Charter and Codified Ordinances in an amount not to exceed Twenty Thousand Dollars, \$20,000.00.

SECTION 2: That the City Council President is hereby authorized to develop specifications and prepare advertisements to accomplish the aforesaid desired objectives, the cost of which shall be charged against the proper appropriation account.

SECTION 3. That there is hereby appropriated from the general fund a sufficient sum of money to pay the costs of carrying out the authorization and directions of this Ordinance including the publication of Notices requested hereunder.

SECTION 4. That the Director of Finance be, and she is hereby authorized and directed to pay from the General Fund, the sums necessary for the indebtedness hereby incurred.

SECTION 5. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution was adopted in an open meeting of

this Council, and that all such deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public according to all legal requirements.

SECTION 6. It is found and determined that all formal actions of the Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all such deliberations of this Council and any of its Committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

SECTION 7. This Resolution shall take effect and be in force from and after the earliest period allowed by law.






