A RESOLUTION AUTHORIZING THE MAYOR TO CONTRACT WITH STEPHEN HOVANCSEK & ASSOCIATES TO PROVIDE ENGINEERING SERVICES FOR THE CITY'S 2018 STREET RESURFACING PROJECTS FOR SURVEYING, ENGINEERING DESIGN, PREPARATION OF CONSTRUCTION SPECIFICATIONS AND CONSTRUCTION ADMINISTRATION, AS-BUILTS, CHANGE ORDERS AND PROJECT FINAL CLOSE-OUT AND CONSTRUCTION INSPECTION FOR AN ESTIMATED 9,400 SY OF STREET RESURFACING IN AN AMOUNT NOT TO EXCEED \$48,000.00

**WHEREAS**, the City of East Cleveland intends to use Community Development Block Grant (CDBG) Funding for 2018 street resurfacing projects estimated to be 9,400 SY; and

**WHEREAS**, an engineer is required to oversee the street resurfacing projects from commencement to completion, including preparation and/or review of specifications for the projects; and

**WHEREAS**, the engineering firm of Stephen Hovancsek & Associates submitted the only bid at the rate not to exceed \$48,000.00.

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the City of East Cleveland, Ohio, three-fifths (3/5) concurring:

**SECTION 1.** That the Council hereby authorizes the Mayor to contract with Stephen Hovancsek & Associates to provide engineering services for the City's 2018 Street Resurfacing Projects estimated to be 9,400 SY not to exceed \$48,000.00.

**SECTION 2** That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all such deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.


**SECTION 3.** That this Resolution shall take effect and be in force from and after the earliest period allowed by law.




