

RESOLUTION NO. 34-18

A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY FISCAL OFFICER FOR TAX YEAR 2019; AND DECLARING AN EMERGENCY FOR THE PRESERVATION OF THE PUBLIC PEACE, PROPERTY, HEALTH AND SAFETY TO MEET THE SUBMISSION DEADLINE OF OCTOBER 1, 2018.

WHEREAS, East Cleveland City Council is charged each year with the responsibility of adopting a City tax budget necessary to be levied within and without a ten mill limitation based on amounts and rates that are determined by the Cuyahoga County Budget Commission for the next succeeding fiscal year commencing on the first day of said year; and

WHEREAS, the Cuyahoga County Budget Commission has determined the rate of tax to be levied with and without the ten mill limitation upon the tax duplicate of the City of East Cleveland and such rates have been estimated by the County Fiscal Officer and certified to this Council.

WHEREAS, in order to levy said rates, the County Fiscal Officer requires City Council to accept, authorize and certify the rates and amounts to be levied by enacting a resolution and by forwarding their determination in the form prescribed by the County which the relevant parts thereof have been recorded in the body of this legislation, said form being attached and fully incorporated herein by reference as Exhibit A; and

WHEREAS, City Council's determination must reach the County Fiscal Officer on or before October 1, 2018; and

WHEREAS, this legislation is declared to be an emergency for the preservation of the public peace, property, health and safety to meet the submission deadline of October 1, 2018.

NOW, THEREFORE, BE IT RESOLVED by the Council of the City of East Cleveland, Ohio, four-fifths (4/5) concurring:

SECTION 1. That this Council hereby accepts the amounts and rates of taxes for the year 2019 to be levied as determined by the Budget Commission and as estimated by the County Fiscal Officer and authorizes the necessary tax levies as follows:

The table below displays a Summary of the amount required from General Property Tax approved by the Budget Commission and County Fiscal Officer's Estimated Tax Rates equal.


SECTION 2. That Council hereby authorizes the Mayor to submit to the Cuyahoga County Budget Commission the City's acceptance of said rates set forth in as well as the form of the Resolution set forth in Exhibit "A," all in accordance with applicable law.

SECTION 3. That the Clerk of Council is hereby authorized and directed to transmit to the Cuyahoga County Budget Commission a certified copy of this Resolution upon its passage using the form incorporated herein as Exhibit "A," no later than October 1, 2018.

SECTION 4. That it is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all such deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

SECTION 5. That this Resolution is hereby declared to be an emergency for the preservation of the public peace, property, health and safety to meet the submission deadline of October 1, 2018. Provided it receives the affirmative vote of four-fifths (4/5) of all the members elected to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor; otherwise it shall take effect and be in force from and after the earliest period allowed by law.




