ORDINANCE NO. 01-20

AN ORDINANCE AUTHORIZING THE MAYOR TO CONTINUE THE SERVICES FOR FIVE THOUSAND FIVE HUNDRED DOLLARS (\$5,500) OF THE CUYAHOGA SOIL & WATER CONSERVATION DISTRICT FOR THE PURPOSE OF PROVIDING TECHNICAL ASSISTANCE IN IMPLEMENTING SOIL AND WATER CONSERVATION MEASURES IN ORDER TO IMPLEMENT THE PUBLIC INVOLVEMENT AND PUBLIC EDUCATION (PIPE) REQUIREMENT UNDER THE OHIO EPA MUNICIPAL SEPARATE STORM SEWER DISCHARGE (MS4) PERMIT.

WHEREAS, the East Cleveland City Council passed Ordinance 02-18 authorizing a Memorandum of Understanding between the City of East Cleveland and the Cuyahoga Soil and Water Conservation District; and

WHEREAS, City Council must reauthorize that two year MOU for its continuation.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of East Cleveland, Ohio, three-fifths (3/5) concurring:

SECTION 1. That the Mayor hereby is authorized to execute and deliver a letter for Memorandum of Understanding between the City and the Cuyahoga SWCD on behalf of the City with such changes therein as shall in the opinion of the Director of Law not substantially or materially change the terms and provisions thereof to the detriment of the City of East Cleveland.

SECTION 2. That the City shall be bound by the terms of such Memorandum, including the provision thereof whereby the City agrees to enter into a contract to compensate the Vendor for work performed pursuant to the Memorandum and required in connection with the implementation of the recommendations derived from work performed pursuant to the Memorandum.

SECTION 3. It is found and determined that all formal actions of this Council concerning and relating to the passage of this Resolution were adopted in an open meeting of this Council, and that all such deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

SECTION 3. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
